CONTRACT;

1. We/I hereby agree to abide by the following conditions: the committee shall not be responsible for any injury or loss that may arise or come to the exhibitor or his/her goods from any cause whatsoever, while said premises are being occupied under this agreement.
2. The exhibitor agrees to sell **only handcrafted items** that have been made in your home listed on their contract. **NO kits, store bought or catalog items** are acceptable. We will be monitoring all crafters this

year for future contracts. We are a **HANDCRAFTED ONLY** show. We will be reassessing everyone this year to enforce our hand crafted only rule.

3. Church services are held from the Gazebo on Sunday morning. The exhibitor agrees not to sell or commence any activity during church services. **This rule is strictly enforced, booths must be closed and tables covered until the service is over. NO EXCEPTIONS.**
4. **No vehicles will be permitted into the park.** Unloading and loading must be done at curbside only. If you have a trailer or camper, please do not park them around the park. Parking is available along the ball park across the street. Again, we ask that you please angle park your vehicle to allow for more parking spaces.
5. **No parking on High Street.** You may stop to unload and then move your vehicle.
6. The committee reserves the right to a two week notice of cancellation in order for you to receive a refund of your show fee.
7. The exhibitor agrees to clean their area leaving no debris. There will be a dumpster on the south side of the park in front of the Verizon building for you garbage, please break down any large boxes you may have. **Please leave the cans in the park for customers and visitors.**
8. Spaces are 12' X 12'. This means your poles; stakes and ropes must be inside this area. Spaces are limited to 2 per crafter. With the removal of trees and the planting of new ones, we will need to redesign the spaces for better alignment. If you were here in the past and would like the same space, please let me know by including your space number on the return portion of your contract. I will place you as close as possible to that location. To insure the same space, return your contract with the space number by the 1<sup>st</sup> of April.
9. The deadline for returning your contract is April 15, 2009. Please make sure I have your contract by this date. I will be filling any openings immediately.
10. **It is your responsibility to read and fulfill the terms of this contract.**
11. Period dress (long skirts are acceptable) will be optional Saturday.
12. No animals permitted in the park.
